<p><b>Arrival Procedures:</b>          Bus loop is closed to cars 7:45 – 8:30 AM.          6<sup>th</sup> graders report to the cafeteria.          7<sup>th</sup> graders report to the courtyard.          8<sup>th</sup> graders report to the front portico.</p> <p><b>Dismissal Procedures:</b>          Bus loop is closed to cars 2:45 – 3:30 PM.          Students report to CORE where they are dismissed to buses by bus location. Walkers must access the crosswalk and crossing guards to cross Ebenezer Road. Car riders can pick students up on Ebenezer Road, or cycle through the school parking lot.</p>	<p><b>Screening &amp; Testing (<i><a href="#">Safety is Our True North</a></i>)</b></p> <ul style="list-style-type: none"> <li>• All families should screen students for symptoms prior to leaving home.</li> <li>• Please use this <a href="#">checklist</a> to determine if a student should or should not go to school.</li> <li>• Persons with COVID-19 symptoms in school will be required to be tested or will be placed on quarantine, in alignment with guidance from the Maryland Department of Health.</li> </ul>
<p><b>Face Covering (<i><a href="#">Safety is Our True North</a></i>)</b>  <b>Requirements:</b> All persons, regardless of vaccination status, must wear a face covering while inside a school. Exceptions to this requirement are:</p> <ul style="list-style-type: none"> <li>• The person is alone in a private space.</li> <li>• The person is eating or drinking.</li> <li>• The person has a documented physical or developmental disability that makes wearing a mask unsafe.</li> <li>• The person is under the age of two.</li> </ul> <p>The person is a student athlete engaged in the sport in the field of play.</p>	<p><b>Social Distancing (<i><a href="#">Safety is Our True North</a></i>)</b>  <b>Requirements:</b> Physical distancing of students from each other and between students and adults will be provided to the greatest extent possible, considering school enrollment and facility constraints. Strategies include:</p> <ul style="list-style-type: none"> <li>• Use of classroom and cafeteria configurations that provide maximal separation between students.</li> <li>• Plans for arrival, dismissal and change of classes to reduce gathering of students in any area.</li> <li>• Restriction of field trips to day trips only, with plans to reduce exposure to large crowds.</li> <li>• Plans for supervision of restrooms, locker rooms, and school lockers to prevent congregation of students.</li> </ul>
<p><b>Hand Hygiene (<i><a href="#">Safety is Our True North</a></i>)</b>  <b>Requirements:</b> Employees and students have been instructed to adhere to best practices in hand hygiene and respiratory etiquette.          Times for handwashing or use of hand sanitizer to include before and after meals, upon arrival to schools' offices and home, before and after use of any shared items, after use of the restroom, after sneezing/coughing and other time hands are contaminated.</p>	<p><b>Breakfast &amp; Lunch</b></p> <p><b>Breakfast:</b> will be Grab and Go</p> <p><b>Lunch:</b> food choices provided however; snacks will not be sold.</p> <p><b>Seating:</b> Students assigned to a table for contact tracing purposes.</p> 
<p><b>Supplies &amp; Devices:</b>  <b>Bring these items daily</b></p> <ul style="list-style-type: none"> <li>• Fully charged device with cord</li> <li>• Water bottle filled with water</li> <li>• Backpack (without wheels)</li> <li>• Face covering and extra one</li> <li>• Student schedule of classes</li> </ul> 	<p><b>Visitors (<i><a href="#">Safety is Our True North</a></i>)</b></p> <ul style="list-style-type: none"> <li>• To visit a BCPS school, visitors must have an appointment.</li> <li>• Visits will be conducted remotely or outside, whenever possible.</li> <li>• If an indoor visit is required, visitors will be required to wear a face coverings and practice social distancing.</li> <li>• The number of people admitted to the building will be limited.</li> </ul>

BCPS staff will:</p> <ul style="list-style-type: none"> <li>• Perform frequent cleaning and disinfection of high-contact surfaces and any shared items, at least daily.</li> <li>• Promote hand washing before and after touch of shared use items.</li> <li>• Maintain sufficient supplies of soap, paper towels, and hand sanitizer.</li> </ul>
